#### **Release Notes Overview**

Release 2020.1.2 for the Defense Property Accountability System (DPAS) was released on April 17, 2020.

This release includes system change requests and corrects program deficiencies identified by the user community. The update impacts eCatalog, Property Accountability, Mobile Platform, and Warehouse modules.

#### **System Change Request (SCR)**

- Transition the 'view remaining items' toggle into a dropdown that features 4 options
  - o 'view all counted all locations'
  - 'view all counted current location'
  - o 'view all remaining current location'
  - 'view all remaining all locations'
- Allow the existing column headers to be sorted
  - clicking header applies ascending sort
  - clicking again applies descending sort

# Material Release Order (LPWHN35)

#### Help Ticket #37428

 Corrected a deficiency within MRO wherein an MRO could be created in the ICP with characters in the Order Instructions field that the Warehouse MRO screen does not allow. These additional characters are now allowed in MRO within the Warehouse.

#### Help Ticket #37479

• Corrected a deficiency where user was not able to update an MRO due to error "Media Status Code is required when DoDAAC is externally managed". The user is now able to update the Media Status Code if no value is provided for it.

# Sko Catalog AUD (LPCTN06)

## Help Ticket #37462

Corrected a deficiency where stock number was disappearing when adding a serial component to a bulk kit.
The user will no longer be able to select a serial stock number for a bulk kit, and a message will display indicating this fact.

## Master Issue List AUD (LPWHN22)

## Help Ticket #37938

Corrected a deficiency where updating and deleting LIN/TAMCNs for a Master Issue List was erroring.
