Release Notes Overview

Release 2020.1.3 for the Defense Property Accountability System (DPAS) was released on May 08, 2020.

This release includes system change requests and corrects program deficiencies identified by the user community. The update impacts eCatalog, Maintenance and Utilization, Property Accountability, and Warehouse Management modules.

<u>eCatalog</u>

Help Tickets The following eCatalog Help Tickets were closed by this release:

LIN/TAMCN (AUD) (LPCTN03)

Help Ticket #37665

• Corrected a deficiency where users were not able to add previously deleted LIN/TAMCN records.

Stock Number (AUD) (LPCTN01)

Help Ticket #38366

• When pulling Stock Numbers in from FLIS, if no CIC code is in the data, it is defaulted to 0 and the control on the UI is enabled to allow the user to edit it.

Help Ticket #37482

• Corrected a deficiency where the external stock number browse was not operable when the screen was not in maximized state.

Help Ticket #38506

- Corrected a deficiency where shelf life codes were updated in situations that required them to remain the same.
- Ran a script to align the imported shelf life code with the current interface value.

- Updated Mfr Part Nbr AUD with the following:
 - When a user tries to delete a Manufacturer Part Number that has assets attached, the user receives the following error message:
 - o 39: "Data requested for deletion exists on other asset records"
 - When a user tries to delete a Manufacturer Part Number with associated ACTIVE software licenses, the user receives the following error message:
 - o "Error 2159: Cannot delete Manufacturer record with active Software Licenses"

• Corrected a deficiency where stock number validations were failing incorrectly.

Maintenance and Utilization (M&U) Module

System Change Request (SCR)

The following feature, which is a part of Maintenance and Utilization SCR 01328, was implemented by this release:

SCR #01328 - NMC DAC Job

The NMC Report Calculation and NMC Site Setting Auto Closeout are background DAC Jobs which are
utilized for the generation of the NMC Report. The NMC Report Calculation is a DAC Job that runs every 4
hours to gather the information of assets to populate to the NMC Rate Report Data Table. Furthermore, the
NMC Site Setting Auto Closeout is a daily DAC Job to check if an NMC site setting is ready to be updated with
a close out date. It works directly with, and shares the same logic as, the NMC site close out screen. This
automatic process checks whether or not a Site with an assigned reporting code is available to be closed out
for its report period.

SCR #01593 – Member Site Feedback Area

• Enables members to give feedback on the items issued to them, and users to review those comments. This feature can be enabled at the Logistics Program for those who would like to use it.

• Corrected a deficiency where users were not able to remove unassociated LIN/TAMCN size categories from member profiles.

Inventory Activity Inquiry (LPWHQ33)

• Corrected a deficiency where not all aspects of location moves for bulk assets were displaying properly in the Inventory Activity Inquiry.

Issue (Warehouse) (LPWHN73)

• Corrected a deficiency where duplicate document numbers were created by Warehouse Issue when issuing multiple assets of the same serialized Stock Number, thereby causing the 867I transactions to get suspended in the ICP.

Inspection AUD (LPWHN88)

Help Tickets #36052 and #36288

• Corrected a deficiency where an inspected kit that contains one or more components with missed scheduled inspections, and thereby had downgraded condition codes, throws the error "Unable to find SKO Build information to update SKO Stock Number qty."



DW Fm 04 Issue List (LPWHR10)

- Updated the sort of the DW Fm04U.
 - Records are separated by commodity type.
 - Within each commodity type, the non-kits are listed first and sorted by Item Desc, Serial Nbr, Stock Nbr, ICN.
 - Next, the kits are listed for that commodity type, and sorted by Item Desc, Serial Nbr, Stock Nbr, ICN.
