### **System Change Request (SCR)**

The following features were implemented by this release:

### SCR #01492 – Expiring Items Report to include Next Inspection in algorithm

• Updated the Expiring Items Report to allow it to account for the inspection schedule of kit components and the kits in which they are contained. When "Include Inspections" is selected upon running the report, the expiration date of the kit components are moved up to the date of the nearest future inspection based on the inspection schedule and latest inspection information of both the component itself and the kit in which it is contained. This is only for when there are inspections already set up for those components and kits.

Updated the Stock Number Activity Report to allow the user to select either multiple Stock Numbers or a
LIN/TAMCN, with each single stock number chosen residing in its' own tab. The maximum number of stock
numbers allowed to be run at one time is 500. Also updated the date selector to allow the user to select a
fiscal year range, fiscal year and month range, or month and year range, instead of selecting two specific
dates for the desired date range.
