## **Release Notes Overview**

Release 2020.2 for the Defense Property Accountability System (DPAS) was released on June 26, 2020.

This release includes both system change requests and corrected program deficiencies identified by the user community. The update impacts eCatalog, Maintenance and Utilization, Materiel Management, Property Accountability, SA/LW Registry, and Warehouse Management modules.

# <u>eCatalog</u>

### System Change Request (SCR)

The following feature was implemented by this release:

### SCR #01241 – DPAS Catalog – Add basic SKO Catalog functionality for PA use

• Added 1 new screen – SKO category – within the eCatalog module under the Catalog menu in PA.

## Maintenance and Utilization (M&U) Module

### System Change Request (SCR)

The following feature was implemented by this release:

#### SCR #01328 - NMC Reporting

• Provided Non Mission Capable Reporting by Line Item Number and Non Mission Capable Inquiries.

## Materiel Management (ICP) Module

#### System Change Request (SCR)

The following features were implemented by this release:

### SCR #01177 – Modify DPAS to Support the Receipt and Management of Customer Requisitions

- Added automated functionality to update an RSA DoDAAC and/or RIC within the ICP module when a matching Warehouse DoDAAC and/or RIC is updated within the Warehouse Management module.
- The ICP will include a new suite of functionality to create and manage Disposal Release Orders that are sent to a client RSA. Similar to the existing Customer Requisition functionality, this process will allow the ICP to select inventory to be disposed and issue a DLMS 940R down to the RSA for disposal. The RSA will generate the 945A to the ICP and the 1348 to send to DLA Disposition Services along with the disposal inventory.

### SCR #01016 - Air Force GFM-A - Accountability and Accounting for OM&S

• The ICP will process reversals of previously sent inventory affecting DLMS transactions. This includes the DLMS 527R (Receipt), 947I (Inventory Adjustment), and 867I (Issue). When the ICP receives a reversal, it will attempt to revert the quantity change that happened by that previous transaction, if the inventory is still present.



# **Property Accountability (PA) Module**

#### System Change Request (SCR)

The following features were implemented by this release:

### SCR #01223 – Use of DA Forms

- Provided DA Form 4949 "Administrative Adjustment Report" for generation.
- Provided DA Form 581 "Request for Issue or Turn-in of Ammunition" for generation.

#### SCR #01551 – Add X807 Accounting Transaction LMP Interface

• Added X807 and X806 Transactions to the LMP interface.

#### SCR #01558 – WAWF GFP TS Improvements

• Updated iRapt/WAWF transactions to reflect PIEE changes for GFP.

• Corrected a deficiency where users were unable to locate inventories for update.

### Stock Number/Selected Mass Change (WPCTN02)

#### Help Ticket #26266

Corrected a deficiency where all stock numbers were not getting successfully updated in a mass update / stock number update attempt.

• Corrected a deficiency where users were unable to select a manufacturer entry on the manufacturer entry browse.

## **SA/LW Registry Module**

#### System Change Request (SCR)

The following feature was implemented by this release:

#### SCR #01303 – Registry Infrastructure to Prepare External Reporting

 DPAS' existing event structure for handling SA/LW assets between WH/PA and the Registry module will be updated to support an upcoming feature for sending DLMS transactions outbound for SA/LW assets where the Owning DoDAAC (WH) or Accountable UIC (PA) has configured to report their SA/LW to an external component Registry.

## Warehouse Management (WM) Module

#### System Change Request (SCR)

The following features were implemented by this release:

#### SCR #01191 – Duplicate member profiles

• Users will now be able to combine 2 member profiles into a single member profile, allowing them to remove duplicate profiles themselves, without contacting the helpdesk for support.



### SCR #01504 – Receiving Documents Inquiry Total Price

• The Document Inquiry will now show the total price of any receipt documents, calculated based on the quantity accepted for that receipt and the stock number unit price of the item.

#### SCR #01331 – Deferred Parts process in WH

- Provided new fields in Work Order inquiry and add deferred Parts Inquiry.
- Altered Warehouse Replenishment to support deferred parts.

### SCR #01560 – Mandatory Fields in Customer Profile

• FAD, media status, and condition code will not be mandatory fields in the customer profile build, they will be static.

#### SCR #01566 – Data on DD1348-1A

• When processing / printing a DD 1348-1A during the materiel release order (MRO), the continuation form will print up to 25-50 serial numbers with UII information.

#### SCR #01569 - Stock Nbr Activity Report

• Added a new report that will show the historical issues, backorders, receipts, and inventory adjustments, along with the current on hand quantity, for a given stock number and a date range.

### SCR #01592 – Repair Parts Inquiry by Component Stock Number

• Added a new report that will show repair parts used within a given date range for a given set of end item stock numbers and/or repair part stock numbers.

#### **Help Tickets**

• Corrected a deficiency within the QA/QC process where changing out bulk components of a kit after updating information regarding serialized components of the same kit, caused the changes to the serialized components to revert back to their original values.

#### Sets Kits Outfits - Build (LPWHN41)

• Corrected a deficiency where duplicate inspection fields and javascript errors were showing up when a kit was built and inspected in one warehouse and subsequently transferred to another warehouse and inspected again there.
