## Release Notes Overview

Release 2020.3.1 for the Defense Property Accountability System (DPAS) was released on October 23, 2020.

This release includes system change requests and corrects program deficiencies identified by the user community. The update impacts Enterprise, eCatalog, Property Accountability, Materiel Management, Mobile Platform and Warehouse modules.

## eCatalog

### Help Tickets

The following eCatalog Help Tickets were closed by this release:

#### *Agency Catalog Stock Nbr Update (LPCTI06)*

Help Ticket #43315

- Changed validation on Catalog Update so that changes in the Demil Code and/CIIC will not be stopped by attached inventory.

Help Ticket #44481

- Corrected a deficiency where incorrect unit of issue was displaying for the inventory.

#### *WebFlis Catalog Data Validation and Staging (LPCTI29)*

Help Ticket #43628

- AF Budget Code, AF fund code, and AF management code from FLIS management line gets pulled into EASN. Then when SN is added, that same data is pulled into SN table.

#### *Stock Number (AUD) (LPCTN01)*

Help Ticket #43755

- Corrected a deficiency where user was not able to scroll the screen to select ECC cd and the select box was not visible at the bottom of the browse screen.

Help Ticket #43681

- Corrected a deficiency where user was not able to delete stock number in warehouse module.

Help Ticket #43964

- Corrected a deficiency where removing the last calibration type inspection from a stock number did not clear the next calibration date from the associated ICNs, which now prevented the user from upgrading any inventory for the ICN to the correct condition code.

## Materiel Management

### **System Change Request (SCR)**

The following feature, which is a part of Materiel Management SCR 1616, was implemented by this release:

SCR #1616 – Provide Visibility of USCG Exchange Inventory

- Modified DPAS to inbound USCG Exchange uniform inventory and provided a view of the inventory.

## Mobile Platform

### **System Change Request (SCR)**

The following feature, which is a part of Mobile Platform SCR 1597, was implemented by this release:

SCR #1597 – Materiel Movement - SKO

- With this feature the following enhancements were added to the Materiel Movement (AIT) process:
  - Allow movement of SKO Kits
  - Allow movement of Components of SKO Kits

The following feature, which is a part of Enterprise SCR 1632, was implemented by this release:

SCR #1632 – PA DLMS Changes for UIC, DODAAC and Address

- Updated labels for DLMS transactions types on Actbl UIC/UIC AUD, UIC DoDAAC/CAGE A/D, and Address AUD screens; Allowed for updating DLMS checkboxes for UIC DoDAAC/CAGE when deleted and reactivated.
