Release Notes Overview

Release 2020.3.2 for the Defense Property Accountability System (DPAS) was released on November 13, 2020.

This release includes system change requests and corrects program deficiencies identified by the user community. The update impacts Enterprise, eCatalog, Inventory, Property Accountability, Maintenance and Utilization, Materiel Management and Warehouse Management modules.

Enterprise

System Change Request (SCR)

The following feature was implemented by this release:

SCR #01632 - PA DLMS 856S/527D Changes

 Updated the 527D/856S DLMS process to make MILS fields available for users to select values, and make the RIC fields optional for the "From" and "To" addresses.

System Change Request (SCR)

The following features were implemented by this release:

SCRs #01585 and 01620 - USMC NAF Real Property enhancements

- Created the ability to set an override on an Inspection Due Date with a meter reading, set at the NSN level.
- Allow users to enter multiple configuration records with additional detail, including internal condition index, and a new description field.
- Allow users to track facility condition rating.
- Added the ability to track additional facility condition rating for facility condition reviews.
