Release Notes Overview

Release 2020.3 for the Defense Property Accountability System (DPAS) was released on October 9, 2020.

This release includes system change requests and corrects program deficiencies identified by the user community. The update impacts Property Accountability, Maintenance and Utilization, Materiel Management, and Warehouse Management modules.

Maintenance and Utilization (M&U) Module

System Change Request (SCR)

The following features were partially implemented by this release:

SCR #01328 - NMC Reporting PART III: Adding NMC Search Parameters

• Added additional parameters (MAM Filter) to the NMC Summary Roll up Report and the NMC Inquiry.

SCR #01532 - Centralized Work Order Creation

Added the availability of all work plan type codes during Schedule Preventive Maintenance; the addition of a
new field on the Work Plan AUD pages, "Central Work Plan" checkbox, that will be fully functional in a later
release. (Much of this SCR will be visible to users in later releases.)

• Modified ICP to include Inbound USCG Exchange Uniform Inventory and provided a view of the inventory.

SCR #01177 - ICP Capability to Manually Cancel a Disposal Release Order

• Updated ICP to allow the ability to manually cancel a Disposal Release Order via the user interface.

Warehouse Management (WM) Module

System Change Request (SCR)

The following features were partially implemented by this release:

SCR #01597 – Transition Ad Hoc Move from HHT to Web Page

- Provides the capability to move an asset from one location to another or from a location into a container, or from a container to a location by scanning of asset/materiel, location, and container label.
- Provides the capability to move a container from one location to another.
- Materiel Movements can be uploaded to the DPAS server to update inventory records, and viewed using the Inventory Activity Inquiry.
- Materiel Movements can be used in an untethered/non-network mode, on any approved device that is capable of hosting a DPAS session.



SCR #01550 - Override Inspection with Meter Reading

Created the ability to set an override on an inspection due date with a meter reading, set at the NSN level.

SCR #01331 - Deferred Parts Work Order

• The Deferred Parts process is completed from the start (in the Work Order Parts tab in M&U) to the finish (using the Warehouse Receipt).
