Release Notes Overview

Release 2021.3.1 for the Defense Property Accountability System (DPAS) was released on September 24, 2021.

This release includes system change requests and corrects program deficiencies identified by the user community. The update impacts Materiel Management (ICP), Maintenance and Utilization, Property Accountability and Warehouse Management modules.

Materiel Management (ICP) Module

Help Ticket

The following Materiel Management Help Ticket was closed by this release:

DLMS Outbound (LPGLI04)

Help Ticket #56011

- Corrected a deficiency where an outbound DLMS 870S transaction with an AE8 Document ID was incorrectly displaying SN in the Unit of Issue.

Maintenance and Utilization (MU) Module

System Change Request (SCR)

The following Maintenance and Utilization features, which are part of SCR 00635, were implemented in this release:

SCR #00635 - Add new Operator Dispatch Report (TRAMS)

- Added a new report that displays the Drivers to and from locations and times for all assigned dispatches on a given day.

SCR #00635 - Add new Dispatch Schedule Report (TRAMS)

- Added a new report that displays a rolled up view by Commitment Id for a given date range.

SCR #00635 - TRAMS role updates

- Updated a new role for Dispatch Requests to allow access only to add dispatches in requested status and to update them to canceled status. No other status can be selected by this role.

Help Tickets

The following Maintenance and Utilization help tickets were closed in this release:

Maintenance Team AUD (WPMAN07)

Help Ticket # 57876

- Corrected a deficiency where Requisition was only storing the last 5 characters of a serial number. Additionally an error message was added as a hard stop when the required number of characters was not entered for the serial number.

Help Ticket # 57877

- Corrected a deficiency where using a space in the Team Name and Team ID generated a 503 Error Code.

Property Accountability (PA) Module

System Change Request (SCR)

The following Property Accountability feature, which is part of SCR 01633, was implemented in this release:

SCR #01633 – Cross module usability of Catalog Management

- Added the Maintenance Group ID to the Stock Number Inquiry screen.

Help Tickets

The following Property Accountability help tickets were closed in this release:

Asset Update (WPHRN51)

Help Ticket # 42094

- Corrected a deficiency where the same price amount is incorrectly being displayed for different amounts of the same bulk items.

Help Ticket # 55141

- Corrected a deficiency where performing a Location Move of bulk assets which contained multiple attachments, a soft delete was performed on the asset record and neglected the file references. This resulted in an issue when the asset was returned to the original Location.

Stock Number/Selected Mass Change (WPCTN02)

Help Ticket # 54244

- Corrected a deficiency where attempting to perform a Catalog Mass Update from one stock number to another generated an Error 83 “Unexpected error encountered, contact DPAS Help Desk for assistance.”

CIP Project Planning (WPACN30)

Help Ticket # 57880

- Corrected a deficiency where the contact role change is not being retained.

Warehouse Management (WM) Module

- Corrected a deficiency where a newly created UIC would not be deleted.

Member Profile AUD (LPWHN25)

- Corrected a deficiency where the Secondary ID field in Member Profile was locked into a 10 digit requirement. The field is now allowed to be less than ten digits.

Inspection AUD (LPWHN88)

Help Ticket # 55763

- Corrected a deficiency where a user could not see anything past page one while on the QA/QC/Inspection screen.

Inventory Update Manager (LPWHN52)

Help Ticket # 56632

- Corrected a deficiency where when performing a Re-Identification of an ICN and changing the expiration date generated an Error 83 "Unexpected error encountered, contact DPAS Help Desk for assistance."

Owning DoDAAC AUD (LPWHN70)

Help Ticket # 57879

- Corrected a deficiency where updating a DoDAAC would return an error to select a contract, yet the Contract dropdown was empty.
