Release Notes Overview

Release 2021.4.1 for the Defense Property Accountability System (DPAS) was released on January 07, 2022.

This release includes system change requests and corrects program deficiencies identified by the user community. The update impacts Catalog, Maintenance and Utilization, Property Accountability, and Warehouse Management modules.

Catalog

Help Ticket

The following Catalog Help Ticket was closed by this release:

Stock Number (AUD) (LPCTN01)

Help Ticket #60850

- Corrected deficiencies where:
 - An ellipses indicator on the select checkbox column in the Stock Number search results grid was sometimes unnecessarily present.
 - When adding/updating a stock number that is not a stock item type J (MCN), the NCB Cd field was not clearly identifiable as disabled by visual effect.
 - The catalog pages in the ICP module were taking an unreasonable amount of time to load in Internet Explorer.

- Updates were made to CIP and Project Planning to track projects in the same manner.
 - CIP Funding Search browse reviewing how funding records are retrieved.
 - CIP Fiscal Year validation allows for older funding records.
 - Add Design Bid Build to Cost record Cost Type dropdown.
 - o Add NAF LOAs.
