Release Notes Overview

Release 2021.4.2 for the Defense Property Accountability System (DPAS) was released on January 28, 2022.

This release includes System Change Requests and corrects program deficiencies identified by the user community. The update impacts Catalog, Inventory Control Point, Maintenance and Utilization, Property Accountability, and Warehouse Management modules.

- Corrected a deficiency where error messages were not displayed on the screen when adding or updating a Manufacturer Part Number.

Maintenance and Utilization (M&U) Module

System Change Requests (SCR)

The following feature, which is a part of SCR 01743, was implemented by this release:

SCR # 01743 - LMP FTAC Updates

- This feature updated the Logistics Management Program (LMP) financial transaction action codes (FTAC) to be consistent with US Treasury pro-forma entries for the disposal of capital assets.

The following feature, which is a part of SCR 01574, was implemented by this release:

SCR # 01574 - ILS-S Requisition Status on M&U Work Order Review

- This feature provides a new tab on the sub work order viewer of the M&U work order page. It allows the user to view Requisitions that exist for that sub work order.

Asset Preventive Maintenance Schedule Inquiry (WPMAQ08)

- Corrected a deficiency where the Asset Preventive Maintenance Schedule Inquiry incorrectly reflected the Asset Last Utilization Quantity as either “1” or null.

- Corrected a deficiency where Schedule Maintenance Inquiries were not populating the Last Utilization Quantity.

Auto Generate Work Orders (WPSAB52)

Help Ticket #60888

- Corrected a deficiency where the Asset Next Utilization Quantity did not correctly calculate based on Maintenance Schedule’s interval of 7,500 miles.

Help Ticket #61668

- Corrected a deficiency where Schedule Maintenance was not updating the Next Utilization Quantity correctly.

Maintenance Schedule Asset Assignment (WPMAN45)

Help Ticket #60627

- Corrected a deficiency where there was a conflict in the data displayed between the Schedule Maintenance and Schedule Preventative Maintenance – Asset Assignment screens.

Help Ticket #59720

- Corrected a deficiency when attempting to view specific assets assigned to a Maintenance Schedule, an error message “No Maintenance Schedule Found” was displayed despite the Schedule having the asset assigned to it.

Maintenance Schedule AUD (WPMAN46)

Help Ticket #56870

- Corrected a deficiency where a maintenance schedule error was not bringing back the correct asset ID and specific values.

Requisition (LPRMN01)

Help Ticket #58494

- Corrected a deficiency where Mission Impaired Capability Awaiting Parts (MICAP) listed as Backorder was not loaded in Integrated Logistics Support-Supply (ILS-S). The Urgency Justification Codes table (UJC) was changed, yet ILS-S had no response.

- Corrected a deficiency where a closed Work Order was not displaying correctly.

- Corrected a deficiency when an Inventory Control Point (ICP) generated Materiel Release Order (MRO) was selected, the Special Instructions field of the MRO was disabled and could not be edited.

- Corrected a deficiency where shelf-life extension was not updating existing inventory expiration dates.

Real-Time Report - Aircraft Inventory Status Report (LPWHR96)

- Corrected a deficiency where the filters for Inspection Due did not have the right filters for dates.

- Corrected a deficiency where the Personnel Master Import job was failing to run.
