Release Notes Overview

Release 2022.1.3 for the Defense Property Accountability System (DPAS) was released on June 03, 2022.

This release includes system change requests and corrects program deficiencies identified by the user community. The update impacts Catalog, Maintenance and Utilization, Property Accountability and Warehouse Management modules.

Catalog

System Change Request (SCR)

- This feature enables export functionality on LIN/TAMCN and Size Category screens.
