### **Release Notes Overview**

Release 2022.2.1 for the Defense Property Accountability System (DPAS) was released on September 09, 2022.

## Warehouse Management (WM) Module

### **System Change Request (SCR)**

The following feature, which is part of Warehouse Management SCR 01372, was implemented by this release:

#### SCR # 01372 - Individual Issue / Stock Nbr Search Improvement

• Individual Issue has been updated to only return Stock Numbers that are a stock item of a DoDAAC that is managed by the currently accessed Warehouse.

The following feature, which is part of Warehouse Management SCR 01373, was implemented by this release:

#### SCR # 01373 - Individual Issue / IntelliSense Stock Nbr field and Item Desc

• Stock Number and Item Desc have been combined into one field in Individual Issue to allow searching for any combination of Stock Number and/or Item Desc.

The following feature, which is part of Warehouse Management SCR 01572, was implemented by this release:

### SCR # 01572 - Disposition / Production Deployment

- An "Excess" formatted DD Fm 1348-1a and addendums can be produced as necessary.
- A DLMS 856S transaction for the Excess materiel that includes Shipment information (Mode of Shipment, Shipment Date, Shipment Nbr, SCAC, etc.) can be produced.
- Full access to Work Flow Approvals are available.

The following feature, which is part of Warehouse Management SCR 01674, was implemented by this release:

## SCR # 01674 - Appt Scheduler / Recurring scheduling options (Monthly / Yearly)

- Ability to add appointment recurrence patterns for service centers within Calendar Management.
  - o Recurrence patterns can be established monthly or yearly for scheduled services.
- Ability to edit appointment recurrence patterns for service centers within Calendar Management.
- Ability to delete multiple appointment recurrence patterns for service centers within Calendar Management.
- Removed the ability to Edit 'In Progress' appointments from Member Login.

## *Inventory Update Manger (LPWHN52)*

#### Help Ticket #42387

 Corrected a deficiency when users made a change to the Manufacturer Contract, Date, or Lot in the Warehouse module, the Inventory Update process categorized these changes as Accounting (AE). The DLMS transactions generated from this process had the wrong Adjustment Reason which perpetuates incorrect data on the ICP level for financial reporting.

• Corrected a deficiency where 2520 920 OSS with TCTO 14D3-13-501, which was rescinded since 19 Dec 2020, was still coming due on brand new built SKOs.
