Release Notes Overview

Release 2022.2.2 for the Defense Property Accountability System (DPAS) was released on September 23, 2022.

This release corrects program deficiencies identified by the user community. The update impacts Inventory Control Point, Maintenance and Utilization, Property Accountability, and Warehouse Management modules.

Inventory Control Point (ICP) Module

Help Ticket

The following Inventory Control Point Help Ticket was closed by this release:

CFO Accounting Detail Report (LPMAR04)

Help Ticket #58497

- Corrected a deficiency where the CFO Accounting Detail Report was displaying double the Quantity Count.

Maintenance and Utilization (MU) Module

Help Tickets

The following Maintenance and Utilization Help Tickets were closed by this release:

Maintenance Schedule - Auto Generate Work Order Job (WPSAB52)

- Corrected a deficiency where the auto generated work orders were only populating randomly.

Immediate Work Order Report (WPMAQ04)

Help Ticket #73124

- Corrected a deficiency where printing of the Tech Work Order was removed.

GSA File Upload (WPMAU02)

Help Tickets #73167, #73472 and #73502

- Corrected a deficiency where when uploading Mass File uploads, GSA Fleet uploads, and DLA Fuel uploads, a "983 - User Id must be 1-25 alpha/numeric with supported special character(s) # and underscore" error message was displayed.

DPAS Home (WPSEN01)

Help Tickets #73304 and #64643

- Corrected a deficiency where Open Work Orders displayed from the Open Actions home page menu did not list work orders that were not tied to an asset ID.

Work Order AU (WPMAN12)

Help Ticket #73961

- Corrected a deficiency where a Work Order was closed but an email was not sent; also, the remark text block stayed blank and when the “resend email” button was clicked, the toast message stated “email failed to send”.

Help Ticket #73981

- Corrected a deficiency where the Sub Work Order Details Drawer was blank.

Help Ticket #73210

- Corrected a deficiency where during Work Order AU the Manufacturer Name was displaying the Manufacturer Part Number.

Help Tickets #73491 and #73780

- Corrected a deficiency where no Team was selected, then the user was unable to choose from a complete listing to select a Technician for Labor.

Asset Update (WPHRN51)

Help Ticket #70283

- Corrected a deficiency where the “668 - Cost exceeds non-Accountable limit.” error message was being displayed during a Manufacturer Update of bulk items.

Physical Inventory (LPAID30)

- Corrected a deficiency where during an AIT inventory on a small screen device, changing and saving the location, using the “Only current location” switch set to On, did not refresh the screen.

Warehouse Management (WM) Module

System Change Request (SCR)

The following feature, which is a part of Warehouse SCR 01674, was implemented by this release:

SCR # 01674 - Appt Scheduler / Clean-up expired appointment recurrence patterns

- The effort is to create a background job to remove appointment recurrence patterns once the schedule until date has passed.
 - This will prevent data sitting in the tables that are no longer relevant to the application
 - these patterns are no longer visible within the application and removes the need for users to maintain/manage these records.

The following feature, which is a part of Warehouse SCR 01572, was implemented by this release:

SCR # 01572 - Disposition / Resolved production issues

- The following components need to be incorporated into the modernized disposition screen and Inventory master selection tool
 - Grid Option > Export (Excel, CSV and PDF)
 - Stock Nbr Browse
 - Attachments

The following feature, which is a part of Warehouse SCR 01572, was implemented by this release:

SCR # 01256 - Master Data Repository / MRO Report

- Include the DPAS MRO report in the daily MDR feed.

The following Warehouse Management Help Tickets were closed by this release:

Remove Expired / Rescinded One Time Inspection (Background) (LPWHB38)

Help Ticket #67672

- Corrected a deficiency where TCTOs with a past rescind date did not get removed automatically.

Inspection AUD (LPWHN88)

Help Ticket #73181

- Corrected a deficiency where during a 90-day inspection on the CIACS (E11), entering the current date was not allowed.

Unit Returns (LPWHN47)

Help Ticket #73306

- Corrected a deficiency where no items were shown on the Pending tab if there were Search Criteria in the Reportable Commodity Type field.

Expiring Items Inventory Inquiry (LPWHQ83)

Help Ticket #74197

- Corrected a deficiency where the spelling of Calculated was corrected in the model and search result, but was not corrected in the search.cshtml file, thereby erroring out during a search.

Disposition (LPWHN50)

Help Ticket #73473

- Corrected a deficiency where a row was selected, and the maximum available quantity was not displayed; using the Inventory Counter to change the selected quantity and the row was not selected.

Help Ticket #73474

- Corrected a deficiency where Intellisense was not functioning in the Stock Number field of the Inventory Select screen.

Help Ticket #74037

- Corrected a deficiency where the 1348 form could not be printed before the asset was disposed.

- Corrected a deficiency where the Search Results grid was not populating properly based on the entered Search Criteria.
