Release Notes Overview

Release 2022.2 for the Defense Property Accountability System (DPAS) was released on August 26, 2022.

This release includes System Change Requests and corrects program deficiencies identified by the user community. The update impacts Catalog, Enterprise, Force System Management, Inventory Control Point, Inventory, Maintenance and Utilization, Property Accountability, and Warehouse Management modules.

Catalog

System Change Request (SCR)

The following feature, which is part of Catalog SCR 01777, was implemented by this release:

SCR #01777 – Soft Delete - Implement soft delete functionality within the Warehouse and ICP modules

- This feature adds 'soft delete' functionality of stock numbers in Warehouse and ICP modules. Changes allow users to remove stock numbers from the user's view in the catalog, while maintaining the historical Stock Number inventory associations. These Stock Numbers can be resurrected by the user in the user's catalog.

The following feature, which is part of Catalog SCR 01758, was implemented by this release:

SCR #01758 – Updates to Stock Number / Manufacturer Part Number

- This feature adds enforcement of a 1-to-1 association for a Type B stock number to manufacturer record in the database and stock number add process on the front end. If a user attempts to add a Type B stock number that already has the same CAGE Cd-Part Number combination for another Type B stock number in the catalog, an error is displayed. In addition, this feature includes a data conversion effort that ensures a singular CAGE Cd-Part Number combination for Type B stock numbers in a single catalog.
- This feature adds grid *export* functionality to the Manufacturer Part Number search page using the new tech refresh export drawer component. Users can export up to 500,000 records.

- Corrected a deficiency where manufacturer part number records from AESIP contained unallowable special characters in the Manufacturer Name field leading to front-end errors.

Enterprise

System Change Request (SCR)

The following feature, which is part of Enterprise SCR 01228, was implemented by this release:

SCR #01228 - Disposition / Accept user entered Document Number

- The user now has the ability to enter their own Document Number when creating a Disposition record. If a Document Number is not entered by the user, the system automatically generates a Document Number.

The following feature, which is part of Enterprise SCR 01731, was implemented by this release:

SCR # 01731 - User Queries for All Modules

- This feature improves the Agency Pre-defined Inquiry role to include additional user column data.

The following feature, which is part of SCR 01758, was implemented by this release:

SCR # 01758 - Updates to Stock Number / Manufacturer Part Number

- This feature supports the catalog changes made in release 2022.1 to ensure that Part Number catalog records include the full manufacturer part number and a valid CAGE code when DLMS transactions are processed. This information is used to provide better accuracy when processing DLMS transactions, both inbound and outbound.

Force Systems Management (FSM) Module

System Change Request (SCR)

The following feature, which is part of Force Systems Management SCR 01626, was implemented by this release:

SCR # 01626 - FSM Inquiries Issue

- This feature updates the FSM Inquiries/Authorization Review Inquiry screen to match the FSM Utilities/File Upload template.

The following features, which are part of Force Systems Management SCR 01670, were implemented by this release:

SCR # 01670 - Authorization Management - LIN/TAMCN Authorizations in FSM - Phase 1

- This feature moves all authorizations to FSM, including Stock Number and LIN/TAMCN Authorizations, for more cohesive management.

Inventory Control Point (ICP) Module

System Change Request (SCR)

The following feature, which is a part of Inventory Control Point SCR 01646, was implemented by this release:

SCR # 01646 - GAFS-R Reporting Parameter Updates

- Provides the capability to run financial reports by Fiscal Year and Quarter in the ICP Module. This allows users the ability to pull historical data, including transaction sets for reconciliation and audits.

Inventory

System Change Request (SCR)

The following feature, which is a part of Inventory SCR 01735, was implemented by this release:

SCR # 01735 - Physical Inventory / Sequence Number Handling

Physical Inventory Export

- Added a Sequence Number as a column on the export from Warehouse Physical Inventory.
- Modified the export process to display more descriptive error messages when Inventory sequence cannot be exported.
- Restricted the export button at the header level to enable only for Open statuses.

Physical Inventory Resolution

- Added a Sequence Number as a column on the Warehouse Inventory Template.
- Updated the import process to create/update Physical Inventory transactions at the Sequence Number level.
- Enhanced the import process error handling for invalid uploads.

AIT Physical Inventory

- Added a Sequence Number as a column to be validated on import and included in export for Warehouse Inventories.
- Added the Sequence Number and Sub Header Status columns to the Physical Inventory list for Warehouse Inventories.
- Provide the ability to upload an individual Sequence Number for Warehouse Inventories.

The following Inventory Help Ticket was closed by this release:

Generate/Reprint Reconciliation Report (WPHRR32)

Help Ticket #68605

- Corrected a deficiency where the Inventory Reconciliation Report was not displaying the reconciled assets or only displaying a portion of them, and the signature block at the end of the report was not being displayed.

Maintenance and Utilization (MU) Module

System Change Request (SCR)

The following feature, which is a part of Maintenance and Utilization SCR 01282, was implemented by this release:

SCR # 01282 - Requisition Re-Design (phase 2) / Parts Requisitioning from Warehouse

- This Feature includes the creation of a new Requisition page in the M&U module that will be used for the ordering of Parts for Work Orders.

The following feature, which is a part of Maintenance and Utilization SCR 01634, was implemented by this release:

SCR # 01634 - DPAS M&U Tech Refresh / Work Order

- The Maintenance Asset process has been technologically refreshed. Functionality has been migrated from the existing Maintenance Asset process into a new Maintenance Asset process. This functionality includes profiling maintenance characteristics of a Property Book asset, as well as profiling equipment directly in the Maintenance module if enabled. The Utilization process was additionally enhanced to accept utilization details from the Maintenance Asset process.
- The Work Order process has been technologically refreshed. Functionality has been migrated from the existing Work Order process into a new Work Order process. This functionality includes the creation and updating of Work Orders, along with associated work order details. The enhancements to Work Order allows the process to perform Work Orders on equipment profiled directly in the Maintenance module if enabled, as well as supporting existing Property Book assets. The Utilization process was additionally enhanced to accept utilization from the new Work Order process.

- Corrected a deficiency where the Maintenance Team Name checkbox field name was changed to Maintenance Team ID in Asset Preventative Maintenance Schedule Inquiry.

Property Accountability (PA) Module

System Change Request (SCR)

The following feature, which is a part of Property Accountability SCRs 01614 and 01611, was implemented by this release:

SCR# 01614 and #01611 - WAWF/PIEE - Bulk GFP Returns

- DPAS Property Accountability Module can now process bulk asset loans, receipt acknowledgements, and loan returns with the PIEE GFP module.

The following feature, which is a part of Property Accountability SCR 01780, was implemented by this release:

SCR #01780 PA UI Update

- DPAS Property Accountability Module now has a Style Sheet Update to match other modules.

- Corrected a deficiency where any menu header:
 - would become unresponsive after attempting to generate forms,
 - would become unresponsive after a successful search for any custodian and then searching again with the custodian field blank and clicking update,
 - would become unresponsive after searching for a ticket number from My DPAS - Help Desk Support.

Warehouse Management (WM) Module

System Change Request (SCR)

The following feature, which is part of Warehouse Management SCR 01654, was implemented by this release:

SCR # 01654 - Master Data Repository Additions

- Data Extract for Stock Number information.
- Data Extract for DLMS information.

The following feature, which is part of Warehouse Management SCR 01572, was **not** implemented by this release:

SCR # 01572 - Disposition / DLA Support

- This was **not** implemented as part of this release due to an approval process defect.
- This **will be** available in SAT and deployed as part of the 2022.2.1 release.

The following feature, which is part of Warehouse Management SCR 01674, was implemented by this release:

SCR # 01674 - Appt Scheduler / Recurring scheduling options

- Ability to add or edit appointment recurrence patterns for Service Centers within Calendar Management.
 - Recurrence patterns can be established daily or weekly for scheduled services.
- Ability to delete a single appointment recurrence pattern for Service Centers within Calendar Management.
- Restricted recurrence dates available for selection within Appointment AUD and Member Login based on appointment recurrence set at Service / Service Center level.
- Removed the ability to Edit 'In Progress' appointments from Member Login.

The following feature, which is part of Warehouse Management SCR 01511, was implemented by this release:

SCR # 01511 - Unit Return / Deprecate "Stock Number Rollup" Code

- Removed code for Stock Number Rollup functionality in Unit Returns.

- Corrected a deficiency when conducting an inspection, the due date would backdate a day.
