#### **Release Notes Overview**

Release 6.3.10 for the Defense Property Accountability System (DPAS) was released on January 11, 2019.

This release includes system change requests and corrects program deficiencies identified by the user community. The update impacts the Maintenance and Utilization, Property Accountability, and Warehouse Management Modules.

### Maintenance and Utilization (M&U) Module
