Release Notes Overview

Release 7.2.00 for the Defense Property Accountability System (DPAS) was released on November 8, 2019.

This release includes system change requests and corrects program deficiencies identified by the user community. The update impacts Appt Scheduler, eCatalog, Enterprise, Force Systems management, Property Accountability, Maintenance and Utilization, Materiel Management, Mobile Platform, Registry and Warehouse modules.

Appt Scheduler

System Change Request (SCR)

The following feature, which is a part of Appt Scheduler SCR 1318, was implemented by this release:

SCR #1318 - Member Size Appointments

- Added database columns for member Profile Appointments.
- Added warehouse field on Member Access Site.

<u>eCatalog</u>

System Change Request (SCR)

The following feature, which is a part of eCatalog SCR 1241, was implemented by this release:

SCR #1241 – eCatalog

• The Pending Catalog transactions functionality, currently only available within PA, will be accessible from all modules within DPAS in support of unified catalog functionality.

The following feature, which is a part of eCatalog SCR 416, was implemented by this release:

SCR #416 – Pending Catalog Transactions

• Changes made to ensure that all information provided within the Pending Catalog transaction is available and brought forward into the cataloging process.

The following feature, which is a part of eCatalog SCR 449, was implemented by this release:

SCR #449 - Catalog Expand Mfr Model Nbr

• Expanded the size of the Mfr Part Nbr field within PA to match warehouse in support of the eCatalog. All modules will enforce and maintain the same data sizes for all mfr part number data.

The following feature, which is a part of eCatalog SCR 1307, was implemented by this release:

SCR #1307 - FSM Phrase Data Support

 Changes made to process and maintain FLIS phrase code data with DPAS catalogs in support of the Allocations management projects.

- ICP now supports the DLMS 511M for Customer Requisitions. Requisitioners can submit a modification request (511M) to the ICP for a previous Requisition.
- ICP now supports the DLMS 869A and 869F Inquiries. Requisitioners can submit follow-up requests to the ICP on their previous Requisitions.
- A new report is available for the ICP to display the Time Definite Delivery metrics of each Requisition received by the ICP.

Registry

System Change Request (SCR)

The following feature, which are a part of Registry SCR 1303, were implemented by this release:

SCR #1303 - Add New Registry Module

- Implements the new functionality for reconciling Registry Assets on an annual basis.
- Adds new screens for reviewing historical changes of Registry Assets.
- Adds a new Add/Update/Delete suite of functionality for Accounts in the Registry.
- Implements security restrictions for users with the Serialization Officer role to only view Accounts they are assigned to and their Registry Assets.

Warehouse Management (WM) Module

System Change Request (SCR)

The following feature, which is a part of Warehouse Management SCR 1484, was implemented by this release:

SCR #1484 – OC Select Items

All items from an inspection are no longer selected by default when creating a QC. User can select and
deselect which items to QC at will. Also, only the items from the chosen inspection will show up as available
to select for the QC. Work combined with SCR 1080.



The following feature, which is a part of Warehouse Management SCR 1486, was implemented by this release:

SCR #1486 – DW01 available for non-kitted items with inspections

A new form has been created to show the inspection schedule on any item in inventory, kit or not.

The following feature, which is a part of Warehouse Management SCR 1487, was implemented by this release:

SCR #1487 - Provide ability to add attachments to a location from the results grid

Users can now add and view attachments to locations without having to open up the edit dialog.

The following feature, which is a part of Warehouse Management SCR 1488, was implemented by this release:

SCR #1488 – Electronic Signature options for Form 46

• The Form 46 now prints out with a signature block so users can digitally sign it.

The following feature, which is a part of Warehouse Management SCR 1496, was implemented by this release:

SCR #1496 – Delinquent Warehouse Transfer

• On a per warehouse basis, users can set up an alert to be emailed to the POC of that warehouse notifying them that there are warehouse transfers that are significantly past their expected receipt date. The time of "significantly past their date" is part of the warehouse configuration.

The following feature, which is a part of Warehouse Management SCR 1199, was implemented by this release:

SCR #1199 - TCTO - Component Inspections

• Kits will now show up as due for inspection based on the inspection schedule of their components as well as their own.

The following feature, which is a part of Warehouse Management SCR 1080, was implemented by this release:

SCR #1080 – QC Check select for Insp

• All items from an inspection are no longer selected by default when creating a QC. User can select and deselect which items to QC at will. Also, only the items from the chosen inspection will show up as available to select for the QC. Work combined with SCR 1484.

The following feature, which is a part of Warehouse Management SCR 1350, was implemented by this release:

SCR #1350 - QA-QC Reports

Existing QA-QC Reports (QA/QC Totals and Inspection/QC Completion) have been updated to be filterable
and sortable in excel, and have all been combined into a wrapper report called the QC Metrics Report along
with a new report named the QA/QC Deficiency Summary.
