Release Notes Overview

Release 4.1.30 for the Defense Property Accountability System (DPAS) was released on November 04, 2016.

This release corrects program deficiencies identified by the user community. The update impacts the Warehouse Management, Property Accountability, Maintenance & Utilization and Security modules.

Warehouse Management (WM) Module

• Corrected a deficiency that caused the user to be unable to modify a UIC Custodian when items were currently issued to that custodian.

Update, the pop up would disappear, acting as if the update occurred. However, it did not. Now when the
To Condition field defaults to a different value, an applicable reason code is selected, and Update is clicked,
the condition code will update on the inventory record to reflect the To Condition Code that was defaulted.

DD Form 1348 (LPWHR01)

• Corrected a deficiency that caused the DEMIL Code to be displayed in-correctly on the DD Form 1348 after a disposal action.
