Release Notes Overview

Release 4.1.40 for the Defense Property Accountability System (DPAS) was released on December 09, 2016.

This release includes system change requests and corrects program deficiencies identified by the user community. The update impacts the Maintenance & Utilization, Property Accountability, and Warehouse modules.

Maintenance & Utilization (M&U) Module

Document Inquiry (LPWHQ79)

• Corrected a deficiency that caused a Page Not Found error when selecting the Document Number link in Unit Issue search results.

• Corrected a deficiency that allows the user to enter a single NCB code for all items located within a Container during the Disposal.

• Corrected a deficiency that required the user to select a NSN before the NCB selector would display on the Disposition screen.

Member Activity (LPWHQ36)

Help Ticket #11953

• Corrected an error where members assigned to more than one UIC had all their Unit issues combined in the DW05UC form.

Inventory Update (LPWHN51)

Help Ticket #12043

• Corrected a deficiency that caused the Inventory Update screen to display the earliest Next Inspect Due Date and not the next Inspection Date.

System Change Request (SCR)
