Release Notes Overview

Release 5.0.10 for the Defense Property Accountability System (DPAS) was released on March 10, 2017.

This release corrects program deficiencies identified by the user community. The update impacts the Warehouse Module, Property Accountability Module, and Maintenance & Utilization Module.

Warehouse Management (WM) Module

System Change Requests (SCR)

• The 'Serial Number' field Search Criteria on the Quality Control process page was upgraded to include Intellisense as well as now allows the user to search on a partial match. Prior to this change, the field required an exact match to return a result.

• Corrected a deficiency that caused the user to be unable to move an asset to a new Location that was not the items Stock Item Issue Location due to the sequence of steps being taken by the user.

• Corrected a deficiency that caused the Unit Issue Activity inquiry to not be able to search for all UICs within a Logistics Program.
