## Release Notes Overview

Release 5.2.20 for the Defense Property Accountability System (DPAS) was released on November 17, 2017.

This release includes corrections to program deficiencies identified by the user community. This update impacts Warehouse Management, Property Accountability, and Maintenance and Utilization Modules.

## Warehouse Management Module

### Help Tickets

The following Warehouse Management Help Tickets were closed by this release:

#### *Individual Item Return (LPWHN79)*

- Corrected a deficiency that caused the Individual Item Return process to error out when conducting a return.

- Corrected a deficiency that caused non-returnable items to be displayed on a member's Outstanding Returnable Items form.

- Corrected a deficiency that caused the users to be unable to edit the MRO header information without error.
