Release Notes Overview

Release 6.0.20 for the Defense Property Accountability System (DPAS) was released on March 16, 2018.

This release includes corrections to program deficiencies identified by the user community. This update impacts Warehouse Management, Maintenance and Utilization, and Property Accountability Modules.

Warehouse Management Module
