Release Notes Overview

Release 6.1.00 for the Defense Property Accountability System (DPAS) was released on April 27, 2018.

This release includes corrections to program deficiencies identified by the user community. This update impacts Warehouse Management, Maintenance and Utilization, Property Accountability, and Materiel Management Modules.

Warehouse Management Module

System Change Requests

Delayed Mx Report

- Created the Delayed Mx Report to allow the Warehouse Module the capability to better report vehicle part order status.

CBRNE Over/Under Report

- Created the CBRNE stock over/under report that shows overages and shortages by commodity in relation to min/max stock level.

Aircrew Position Indicator

- Added the Aircrew Position Indicator (API) field on each UIC assignment to show authorized quantities of equipment.
