- Corrected a deficiency where Microsoft Word was incorrectly listed as an option for the MRO Status Report, resulting in an error.

Data Fix (N/A)

- Corrected a deficiency where 527R MRA DLMS transactions were unable to be sent out after completing a receiving document.

- Corrected a deficiency that prevented DoDAAC information from being retained when creating documents and sending DLMS transactions using unique Routing Identifier Codes (RICs).
