Participant Questions and Answers:

Question: What classes/modules in DPAS eLearning do I need to complete to have access to MNU to be able to perform these tasks?

Answer: You will need the M&U MSO in addition to your current role. The course for MSO is DPAS8065, you will also need to submit a role request form with the new role. Also - the training will not be available as a selection in the LMS until this Friday.

Question: What happens to the scheduled maintenance that is already in the system now?

Answer: The current scheduled maint will remain. This is if it's being done at the new centralized level

Question: Do i follow the same process for scheduled or unscheduled maintenance?

Answer: This process is only for creating schedules for maintenance. Unscheduled is entered in a different way.

Question: You don't have to use the days if you don't have a day you want it to come in right?

Answer: Scheduling by day is only one of the options for scheduling. So, you can schedule by day, or week, or month in several different ways. Does that answer your question?

Question: in the USAF we Have to use plans already made by VSCO's. I'm in DPAS and it looks like the old style still to put work plans

Answer: This new option has not been installed yet. It goes in this weekend.

Question: can you have multiple work plans under one work plan?

Answer: You can have any number of work plans in a work order, but, we cannot nest work plans themselves

Question: what number is the MSO role in DPAS training

Answer: It will be DPAS8065. It may not be added as of yet however.

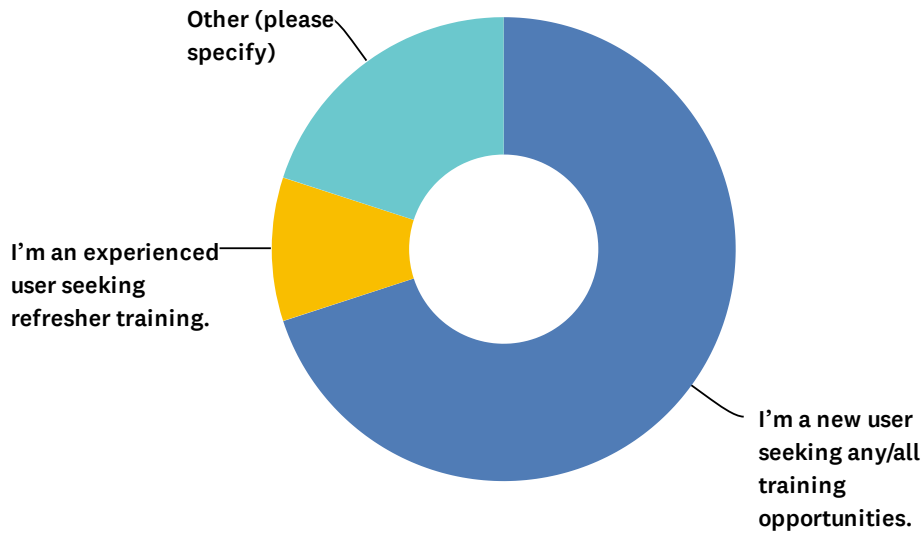
Question: Does the MSO role gives users the ability to create scheduled maintenance and work plans or just scheduled maintenance?

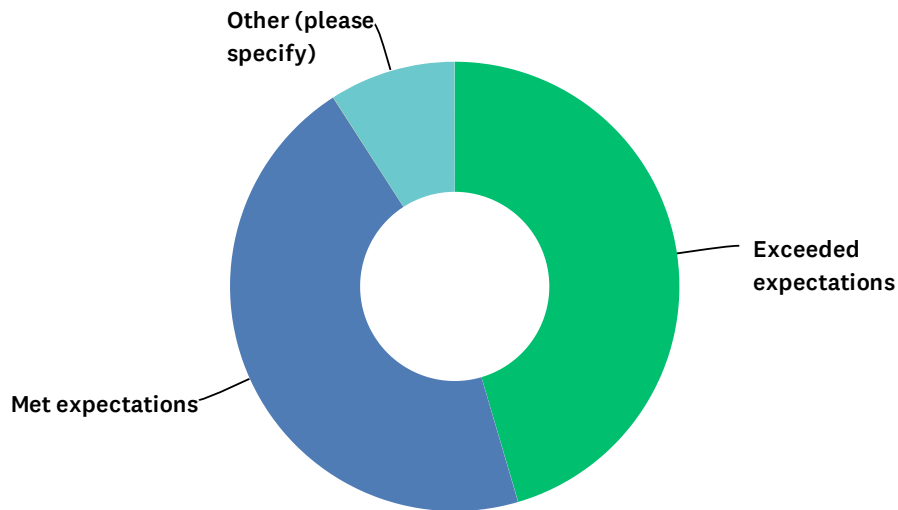

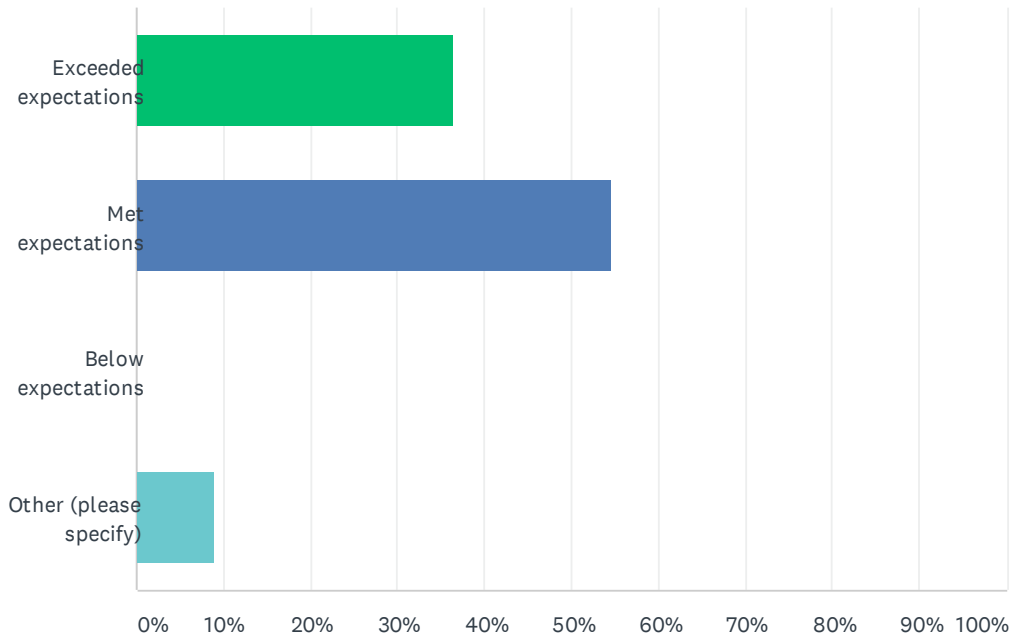

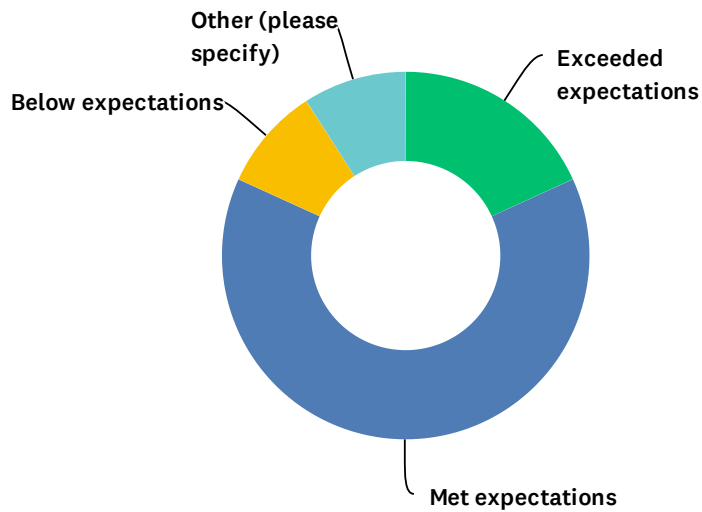

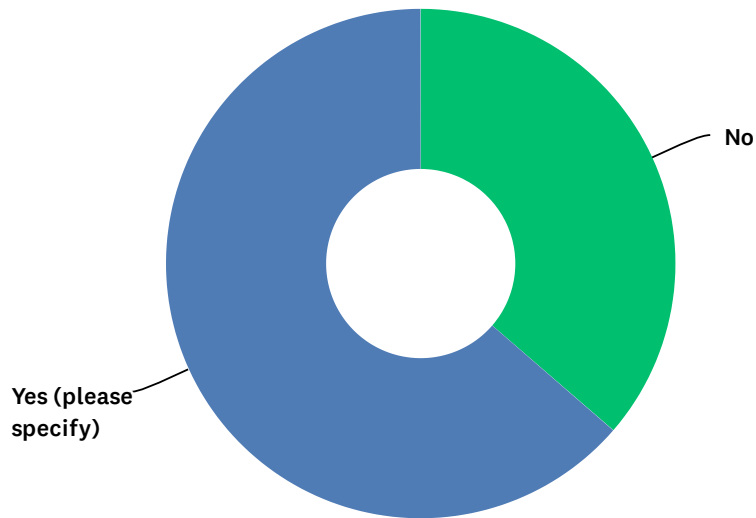
