

**Answer:** Longitude and Latitude is required for FAST however DPAS will automatically convert any address to the Longitude and Latitude for the FAST reporting.

Question: What is the reason for longitude and latitude as opposed to the zip code?

**Answer:** Longitude and Latitude is required for FAST reporting however DPAS will automatically convert the address w/ a zip code for FAST requirements.

**Question:** Are you going to show how to make sure that a vehicle bridges over from Property Accountability to M&U for life cycle?

Question: I have to leave at 2 but it would be helpful to get those slides








