Participant Questions and Answers:

Question: What is the difference between the two Remarks boxes?

Answer: The Remarks box stays with the asset and can be updated anytime and the History Remarks is only a transactional remark and will be saved in the database and be found in the inquiries.

Question: I don't have the option to adjust the Asset Id Prefix... is that just a roles issue

Answer: To use this you have to confirm with your agency first but Asset ID Prefix needs to be set up in the Mater Data before they show in the other processes like Asset Update and Receiving.

Question: Should we use the 'Agency Tab' for saving the previous Asset ID number instead of the remarks or history remarks box

Answer: The Agency Tab is used if your agency has set up Agency Defined Fields. An Agency can select up to 5 if needed. Not all agency uses this capability. Using Remarks and/or attaching the documentation as an attachment is our recommendation.

Question: Question about price/Acq cost: When I add an item to the catalog, I make sure the original procurement price is in the catalog. My question is, if I pull a piece of equipment from the DLA (DRMO) Reutilization Program, what should I list the Acquisition Cost as WHEN ASSET RECEIVING the equipment since the items received from that program are free issue? (sorry for the duplication but I wanted to include all details)

Answer: This is an interesting question since DPAS doesn't allow \$0 in the Acquisition Cost. I would ask your Property or Accounting folks to see if they require. I will also see if there is any guidance on DPAS side.

Question: I see you have contract numbers listed that are not in the standard DFARS format. When we tried to load some numbers for a cooperative agreement but it would not accept the number because it didn't match the FAR contract format

Answer: Have you tried to select another Contract Type Cd within the Contract AUD screens. We have added several other Contact types to allow user to add other contracts. It is still an issue – please contact the DPAS Help Desk at 1-844-843-3727 / DPASSupport@leidos.com

Question: If i receive a "free issue" then I will post it in the remarks and use \$1.00 (one-dollar) as the acquisition cost and post the acquisition documentation

Answer: Thanks for the Recommendation.

Question: can the document number be adjusted to coincide with the Army standard?

Answer: The Document numbers are DPAS generate but you can add an agency generate if you agency has their own but will have to free text or copy and paste. The document number requirement may be set up by your agency to allow an Army Standard if they wish. If they have not requested it to be a "free form" then it must consist of DoDAAC (characters 1 – 6), Julian date (characters 7 – 10), and a serial number (characters 11 – 14). Or a DPAS generated number.

Question: is there a webinar that shows how to do a mass upload of new assets into DPAS? I've heard it can be done in an Excel file, no more than 50

Answer: Asset Receiving Webinar or the Asset Receiving QRG on the DPAS Support Site. You can load 500 assets of the same stock number.

Question: How do you load Contract Numbers that do not fit the standard DFARS contract number format? We tried creating an Master Contract record for a cooperative agreement and it would not accept the number.

Question: Question about price/Acq cost: When I add an item to the catalog, I make sure the original procurement price is in the catalog. My question is, if I pull a piece of equipment from the DLA (DRMO) Reutilization Program, what should I list the Acquisition Cost as since the items received from that program are free issue?

Answer: This is an interesting question since DPAS doesn't allow \$0 in the Acquisition Cost. I would ask your Property or Accounting folks to see if they require. DPAS will allow 0.01 as an entered cost.

Question: Did she go to update to add a 1348?

Answer: 1348's may be generated via a disposition or transfer out. However, if you have one that was part of an original receipt and it needs to be added to the asset, you may go in to Update and do an attachment of the document to the asset.

Question: Does the "wildcard" "%" work throughout all search boxes in DPAS?

Answer: Yes it may be used in most places. **Item Desc** is one place that it may not be used. Special characters such as % are not acceptable. However, a word from the item description may be entered. For example. Item Description - Tank, Combat, Full Tracked may be search by using one of the words without using the %.

Question: Can we get a webinar on how-to setup end items with components and how to transfer components of end items to DRMS ect

Answer: We did a webinar several months ago covering Asset Receiving. Within that webinar we did cover bringing in components and associating to a higher assemblage.

Using Google Chrome go to the Asset Receiving Webinar to see how to bring in and associate components to a higher assemblage <https://dpas.adobeconnect.com/p1zx89rcaz37/> Fast forward to 00:32:03 to see the portion that covers components.

If you wish to transfer just the components of a higher assemblage to DRMS you may do just that. They will be unattached and will transfer. If you transfer the assemblage, the components will follow and will have the serial numbers listed on the 1348/1150.

Question: what type of documentation is needed to make those changes in DPAS.... price , location , etc

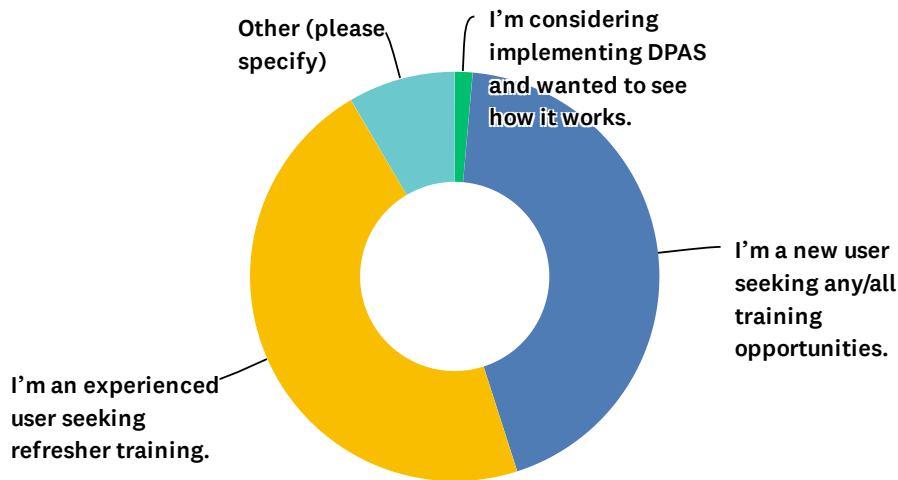

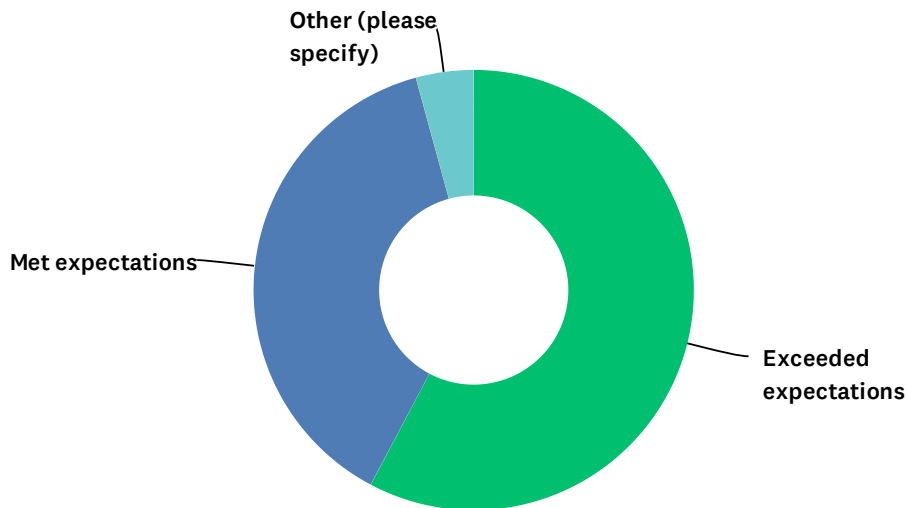

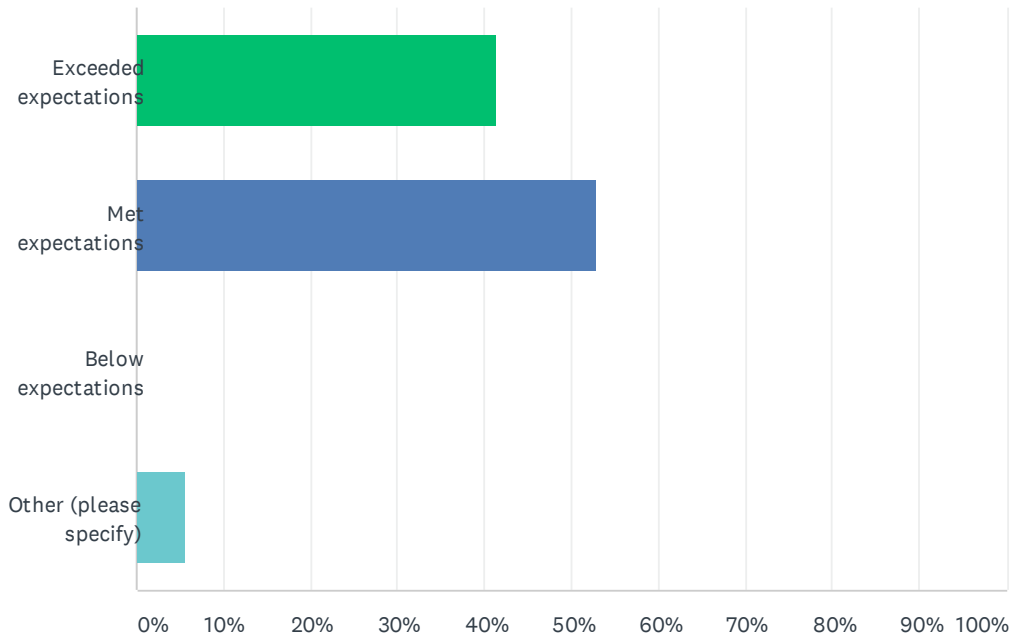

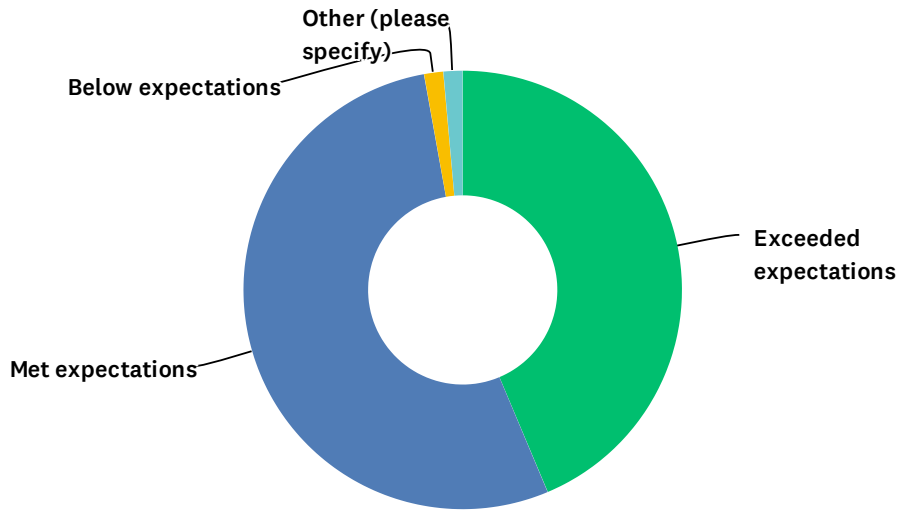

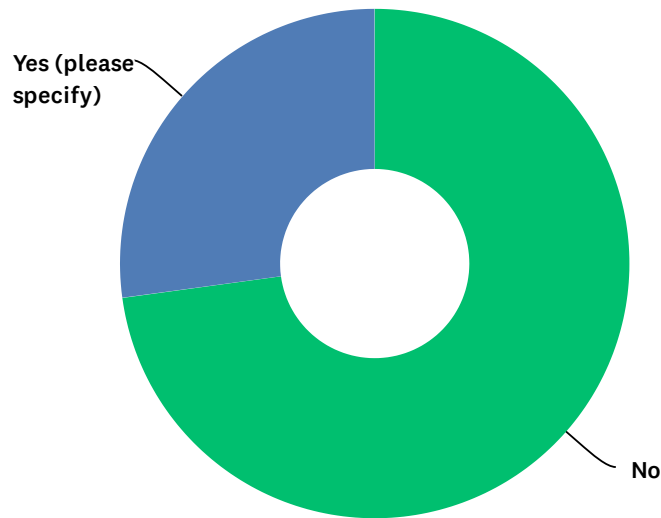
