

Participant Questions and Comments:

QUESTION: What was the code in Pending Transactions for assets being returned from Loan by

Contractor?

ANSWER: Because both the Stock Number and manufacturer are known, because the asset was

already on the property book, the **Status** is *CC* (Catalog Complete)

QUESTION: Can a Contract be set up in the master data as having both GFP and be for an equipment

purchase?

ANSWER: I am afraid not. That would be two different categories. Separate contracts would need

to be created.

QUESTION: Would the Contractor have to be DPAS trained to receive property through WAWF?

ANSWER: The idea behind using DPAS Loans Via WAWF is that all acceptance is done within

WAWF, which most Contractors already know.

QUESTION: Would that have to be stated in contract, that contractor needs to be WAWF trained?

ANSWER: Almost every Contractor has someone who is WAWF trained since that is how the

Contractor gets paid.
